Active Ingredients

A full bottle contains 3158mg broad spectrum extract, derived from cannabis sativa biomass dry 31579mg minimum, containing cannabidiol 3000mg.

Package contains a 50ml bottle, Consumer Medicine Information (CMI) leaflet and dosing syringe.

Each 1mL of Oz Sun CBD100 contains 100 mg/mL CBD (Cannabidiol)

Why have I been prescribed Oz Sun CBD100 Oil?

Your doctor may prescribe this product for a range of medical conditions that have persisted for longer than three months or have not responded to traditional first-line treatments or products. For further information about why this product was prescribed to you, please speak to your prescribing doctor.

Precautions and Warnings

Oz Sun CBD100 Oil is contraindicated (should not be used) for:

1. Women who are pregnant or lactating;
2. Persons with a known or suspected cannabinoid allergy;
3. Persons with serious cardiovascular disease e.g., congestive heart failure; and
4. Persons with personal history of schizophrenia or psychosis.

Oz Sun CBD100 Oil should be used with caution for:

1. Persons with suspected or confirmed family history of serious psychiatric disorders such as schizophrenia, psychosis, major depression, bipolar disorder or personality disorder; and
2. Persons with a history of alcohol or drug abuse or substance dependence.

Do not take Oz Sun CBD100 Oil after the expiry date has passed.

Do not take Oz Sun CBD100 Oil if the packaging is damaged or shows signs of tampering.

Dependence on Oz Sun CBD100 Oil is unlikely but may occur in some persons.

It is recommended to avoid consuming alcohol whilst consuming Oz Sun CBD100 Oil.

Before you start using Oz Sun CBD100 Oil, inform your doctor if:

1. You have allergies to any other medicines;
2. You have allergies to cannabinoids or terpenes;
3. You are pregnant or are planning on becoming pregnant;
4. You have serious liver or kidney problems;
5. You have experienced serious heart problems such as angina, previous heart attacks, uncontrolled or poorly controlled high blood pressure or an irregularity with your heart rate or heartbeat;
6. You are taking Warfarin or any other blood thinners;
7. You are elderly, have difficulty performing activities of daily living (ADLs) such as preparing food or drink, or are at risk to falls and instability; or
8. You are taking any other medicines, including prescription, OTC, and herbal medicines.

If you have not informed your doctor about any of the above, tell them before you begin using Oz Sun CBD100 Oil.

Dosage

Oz Sun CBD100 Oil is for oral use only. Do not use Oz Sun CBD100 Oil without dosing and administration advice from your doctor. If you are unsure about administration or dosage, please consult with your prescribing doctor or pharmacist. Currently, there is no standardised or clinically defined dosage for Oz Sun CBD100 Oil. Following the 'start low, go slow' philosophy of cannabis medicine, all patients will be started on a low dose and titrated under clinical supervision until a therapeutic response is achieved or side effects limit titration. Your optimal dose will be established by you and your doctor by monitoring the effectiveness of each dose and observing for any side effects. Due to the long half-life of oral cannabis medicines, it is recommended to wait a minimum of 6-8 hours between doses. Titration should be conducted in a slow and mindful manner in small increments with the guidance of your prescribing doctor.

Each bottle of Oz Sun CBD100 Oil is supplied with a reusable oral dosing syringe to ensure simple administration

Administration

- 1.Remove child resistant bottle cap by firmly pushing down on the cap, squeeze and rotate counterclockwise. Tamper proof seal will detach on first opening.
- 2.Hold bottle in vertical position and firmly push dosing syringe into the adapter in bottle, ensuring syringe is secure in small central adapter hole.
- 3.Turn bottle upside down, slowly pullback on plunger, drawing oil into the syringe from bottle.
- 4.Pull plunger to desired dose as represented on syringe in printed increments. Carefully check dose.
- 5.Turn bottle right way up before removing syringe from fitting to ensure oil does not leak.
- 6.Replace child resistant bottle cap firmly pushing down, squeeze and rotate clockwise.
- 7.Place tip of syringe inside the mouth and slowly push down plunger. Swallow immediately, do not place under the tongue.
- 8.After every use, wash with warm water and return bottle and syringe

If You Forget A Dose

If you forget to take a dose, take the next dose when you remember and continue to take the next dose at the regular time and interval. If you forget a dose, do not consume a double dose to make up for it as this may increase the risk of experiencing unwanted side effects. If you are unsure or need guidance, please call your doctor or pharmacist.

If You Take Too Much

Common side effects of taking too much THC can include anxiety and paranoia. Whilst this may be unpleasant, the effects are generally short lasting.

If you have preexisting cardiovascular disease, chest pain or shortness of breath please call 000. If you are experiencing suicidal thoughts and ideations, please call lifeline or 000. Once the episode has subsided, please reduce your dose and talk to your prescribing doctor about dose adjustments or medication changes.

Safety Information

Ingestion can result in temporary intoxication, confusion, fatigue, drowsiness and impairment. It is strongly advised that patients refrain from driving or operating heavy machinery while on cannabis based medicines.

For more information on legalities surrounding cannabis medicines, please speak to your doctor or pharmacist.

Drug Interactions

Cannabis may interact with various drugs, including but not limited to the ones listed below.

Drugs Metabolized by Certain Enzymes:

CBD is metabolized by the Cytochrome P450 group of enzymes. As such, consumption of Oz Sun CBD 100 may affect other drugs metabolized by these enzymes.

Highly Protein-Bound Drugs:

There may be potential for Oz Sun CBD 100 to interfere with the action of certain highly protein-bound drugs.

Your health care practitioner may wish to make dose adjustments for such drugs when initiating or increasing the dosage of this drug.

Sedatives and CNS

Depressants:

Oz Sun CBD100 Oil may enhance these effects of any drugs that slow down the central nervous system.

Consult with your health care practitioner if you use sedatives or CNS Depressants, including sleeping pills, tranquilizers, some pain medications, some allergy or cold medications or antiseizure medications

Side Effects

Some patients may experience adverse side effects. Common side effects include diarrhoea, light headedness, drowsiness.

This is not a complete list of side effects. If you experience any side effects or any unexpected effects while using this product, stop consuming the product immediately and contact your health care practitioner.

Storage

All medicines (including cannabis medicines) must be stored safely in a location that children and animals cannot reach. Light and heat can degrade cannabis products.

Store all cannabis products in a cool dark place below 25 degrees celsius, away from direct sunlight.

Do not transfer product material to a different container.

Do not use the product after the expiry date printed on the label.

If seal is broken, do not use.
